

China's carrier sails through Taiwan Strait, stirs scrutiny

BEIJING

CHINA's newest aircraft carrier has sailed through the Taiwan Strait, the navy said Friday. The body of water separates China from Taiwan, the self-governing island that Beijing says must come under its control.

The sailing could serve as a warning to the US and others against support for Taiwan, though China played down any such motive.

The Fujian, which is doing sea trials ahead of its commissioning, was heading to the South China Sea to conduct training and scientific experiments, the navy said in a short post on social media.

The navy said the carrier's activities were not targeting anyone else.

A social media account affiliated with state media quoted an expert saying the Taiwan Strait was the normal and most reasonable and efficient route for the carrier to reach the South China Sea.

It was the first time the Fujian had passed through the strait, the post by the Yuyuantiuan account said.

The US Navy sends warships through the strait periodically, as do some of its allies, in a warning to Beijing against any attempt to use force to establish its claim to the island. Taiwan and China split in a civil war that brought the communists to power in 1949.

The defeated Nationalist government fled to Taiwan and set up its own government on the island.

The US does not officially recognise the government in Taiwan, but it provides weaponry for its defense and says that any resolution of the differences between China and Taiwan should be peaceful and not by military force.

China's military said last week that it was on high alert after the Canadian frigate Quebec and the Australian destroyer Brisbane sailed through the strait.

China's military accused the two warships of provocative actions that it said heightened security risks. AP

Legal parties call parliament dissolution unconstitutional

President Paude's approval of interim prime minister's proposal sparks backlash, with critics warning it erodes democracy and federalism

NEPAL's major political parties and apex lawyers' body have strongly criticised the president's decision to dissolve parliament, describing the move as "unconstitutional," "arbitrary" and a serious blow to democracy.

The criticism followed Friday's recommendation by the first cabinet meeting chaired by interim Prime Minister Sushila Karki to dissolve the House of Representatives, a proposal that President Ram Chandra Paudel promptly approved. The house was dissolved with effect from 11 pm on September 12, 2025, according to a notice issued by the

President's Office. The president also fixed March 21, 2026, as the date for holding fresh parliamentary elections, it said. Political parties across the spectrum slammed the dissolution move. Disapproving of the move, Nepali Congress (NC), the largest political party of the country, warned that any action violating the Constitution would be unacceptable.

The Central Executive Committee meeting of the Nepali Congress held on Saturday concluded that the dissolution of the Parliament has "jeopardised the democratic achievements" of the country. MyRepublica news portal reported. "This move to dissolve parliament is

against the spirit of our Constitution and the interpretation of the Supreme Court. It is absolutely unconstitutional," the NC said in a statement.

NC General Secretary Bishwa Prakash Sharma said any breach of the Constitution raises serious questions.

CPN-UM General Secretary Shankar Pokharel described the move as "ironically concerning". "In the past, the majority of governments' attempts to dissolve Parliament were challenged as unconstitutional. Ironically, those same voices are now supporting this dissolution. We must remain vigilant," the Communist Party of Nepal (Unified Marxist-Leninist) leader was

quoted as saying by the news portal. The CPN (Maoist Centre) also expressed serious disagreement with the decision to dissolve the House of Representatives. Party spokesperson and Vice Chairman Agni Prasad Sapkota said the decision went against the country's constitutional framework. Issuing a late-night statement, the Nepal Bar Association (NBA) said the "arbitrary" dissolution undermines constitutional supremacy and "strikes at the core of constitutionalism". The umbrella body of legal professionals warned that this step weakens Nepal's hard-won democracy and dilutes the achievements of federalism. PTT

FBI head Patel in a soup after blunder in Kirk's probe

HOURS after the assassination of conservative activist Charlie Kirk, FBI Director Kash Patel declared online that "the subject" in the killing was in custody. The shooter was not.

The two men who had been detained were quickly released. Utah officials acknowledged that the gunman remained at large.

The false assurance was more than a slip. It spotlighted the high-stakes uncertainty surrounding Patel's leadership of the bureau when its credibility is under extraordinary pressure, as is his own.

Patel now approaches congressional oversight hearings this coming week facing not just questions about that investigation but broader doubts about whether he can stabilize a federal law enforcement agency fragmented by political fights and internal upheaval.

Democrats are poised to press Patel on a purge of senior executives that has prompted a lawsuit, his pursuit of President Donald Trump's grievances long after the Russia investigation ended, and a realignment of resources that has prioritized the fight against illegal immigration and street crime.

The hearings will offer Patel his most consequential stage

yet, and perhaps the clearest test of whether he can convince the country that the FBI, under his watch, can avoid compounding its mistakes in a time of political violence and deepening distrust.

"Because of the skepticism that some members of the Senate have had and still have, it's extremely important that he perform very well at these oversight hearings" on Tuesday and Wednesday, said Gregory Brower, the FBI's former top congressional affairs official.

The FBI declined to comment about Patel's coming testimony. Kirk's killing was always going to be a closely scrutinized investigation, not only because it was the latest burst of political violence inside the United States but also because of Kirk's friendships with Trump, Patel and other administration figures and allies. Clashes in Pak: 12 soldiers, 35 militants killed

PAKISTANI security forces raided two hideouts of the Pakistani Taliban near the Afghan border in the past two days, triggering fierce clashes that killed 12 soldiers and 35 militants, the military said Saturday. The death toll underscores the struggles Pakistan faces as it tries to rein in resurging militant groups.

The military said 22 militants were killed in the first raid in Bajaur, a district in northwestern Khyber Pakhtunkhwa province.

Thirteen more were killed in a separate operation in South Waziristan district, the military said in a statement on Saturday. AP

A giant pink fish, a colorful peacock, an airplane painted with the national flag. These are just some of Ghana's fantasy coffins, known as Abekumbi, which translates to "proverb."

Each piece is crafted not just to bury the deceased, but to embody the essence of their life. A farmer isn't laid to rest in a car; instead his coffin might take the shape of the tools he used or the crops he cultivated. The design itself becomes metaphor, a wooden riddle, a final message left behind. Fantasy coffins, while common among the Ga people of Accra, are becoming a widespread practice, offering a colorful alternative to simple wooden boxes. When a family loses a loved

one, they gather to decide how to honor them. They visit a carpenter workshop, some with a clear vision, others seeking the carpenter's guidance to create a fitting tribute. The choice depends on each person. A fishmonger might be remembered in the form of the fish he sold, down to its exact type. Lion-shaped coffins are reserved only for chiefs, as the animal is a symbol of power. In

Lahadi, a suburb of Accra, royal families are tied to their emblem, the rooster, a design reserved only for their lineage. The right to a particular coffin is never arbitrary; it reflects identity, occupation and status. Each coffin takes about two weeks to complete. The cost, which starts at around \$700, varies depending on the type of wood and the complexity of the design. AP
